COMMUNICATION TO OWNERS: Bob Weddle -RC President and Kim Corradino-Sentry Management.

"Please be patient. We are working around the clock so owners can return to a safe Environment". Kim and Mike are working remotely with no Power and Limited Internet and Cell Service in Cape Coral. Board Directors communicating daily on every front."

FORT MYERS BEACH

- **FMB:** As of Oct. 5th 2022 Fort Myers Beach is only accessible to EMS and Emergency Services until Monday Oct. 10th.
- Florida Power and Light Posted today, no time estimate for Electric Power to be restored on FMB.
- * FMB Waste Water Treatment Plant "Is down" as of Oct. 4th.
- **Cell Service and Internet Service** Continues to be Disrupted. Sentry Management Importing Mobile WiFi Hotspots into Temporary HQ.
- **Search and Rescue:** Ongoing. Riviera Building 100% Vacant.
- * **Supplies**: Food, Water, Fuel Supplies Critically Low Per Sentry...

RIVIERA PROPERTY

- Hartford Insurance is managing the Insurance process. They are working with Front Line while coordinating with our Riviera/Sentry appointed Independent Public Adjusters.
- The Riviera Entrance / Property is closed until LCM Engineering can enter the Riviera Property in order to establish Structural Integrity of the building. Vendors, workers, owners cannot access the property until deemed safe.
- * Once LCM Engineers gain access to Fort Myers Beach they will coordinate with Hartford for Approved Access
- Fire Department Will Approve Final Access to the Building.
- * Contractors for Cleanup are in the "Q" Once Property Access Is Granted.

RIVIERA ENTRANCE AND PROPERTY ACCESS CLOSED

* Entrance Barrier Will Be Up. DO NOT ENTER PROPERTY SIGNS POSTED.

UNTIL LCM ENGINEERING/HARTFORD DEEMS OUR BUILDING STRUCTURALLY SAFE.

* Date Pending for LCM engineering Inspection. Check Bulletin # 4 due Friday Night Oct. 7th.

- Approved Vendors/Contractors/Workers will have to be registered Online on at the RC Website. Pending.
- Non Registered or Non Approved Contractors will be asked to leave and reported to Lee County Sheriffs Dept.
